COMMERCIAL VEHICLES



Some of our members are employed with jobs that require a company truck or van. If you are in business and have a commercial vehicle that needs to be stored at your home, you may do the following:

- 1. Garage your vehicle at night.
- 2. Obtain a magnetic cover for the commercial sign or a tarp to cover the vehicle each night.

Please review the regulations that apply to commercial vehicles and avoid a violation that will result in a fine. Fines: all violations of Section 6, Subsections 9 of the DOR shall incur a fine of \$100.00 per day or occurrence. The fine is due and payable immediately. If the violation is not corrected and the fines are not paid in full, the Association will file a claim of lien against the property for the assessed fines.

Section 6 - GENERAL PROHIBITIONS AND REQUIREMENTS

9. No boat, motor home, travel trailer, truck (non-commercial trucks excepted) or commercial vehicle except an automobile may be stored overnight on any Lot unless the same be within a garage or carport. Random unavoidable parking of such vehicles must be reported by the homeowner to the Association as soon as possible. III. USE OF MOTORIZED VEHICLES, PARKING; STREETS B 1There shall be no storage or overnight parking of any mobile home, trailer (with or without wheels), motor home, tractor, truck (other than non-commercial pick-up trucks and vans), commercial vehicles of any type, camper, motorized camper or trailer, recreational vehicles, boat or other watercraft, boat trailer, or any other related forms of transportation devices upon any portion of Carolina Shores. For clarification, any vehicle that has commercial lettering is considered a commercial vehicle.

CSPOA BUDGET for 2025 – Kerry Jarrell, Treasurer

The proposed 2025 CSPOA Operating Budget is included in this edition of the bulletin. The Budget includes funding for all anticipated operating expenses for the upcoming year as well as the scheduled contribution to the CSPOA Reserve and Replacement Fund. Member dues have been unchanged for the past five years. Under this proposed budget, member dues would increase from \$290 to \$310 per year. Members are encouraged to review the budget and refer any questions or concerns to the office.
